*The Conservative Strategic Allocation Benchmark is a blended benchmark comprised of 3% UPAL S&P 500 Index Benchmark, 3% UPAL Large Growth Benchmark, 3% UPAL Large Value Benchmark, 4% UPAL Mid Cap Benchmark, 1% UPAL Small Cap Benchmark, 5% UPAL International Benchmark, 2% UPAL Global Public REIT Benchmark, 10% UPAL Alternative Investment Benchmark, 58% UPAL Core Bond Benchmark, 10% UPAL Short Term Income Benchmark and 1% Citigroup 3-month T-bill. The benchmark has been modified during the model's existence. Further information is available upon request.

The underlying asset allocation shown below represents the long-term strategic target employed in the model as of 8/31/2016. These strategic weights may deviate within pre-defined ranges on a tactical, short-term basis (as indicated in allocation descriptions below). Historical returns of the model include asset allocation shifts as well as the returns of terminated managers.
